Public Comment	An opportunity was given for public comment: There was none.
Approval of Minutes	Kate O'Rourke moved to approve the minutes for the December 9 th , 2021 regular board meeting and Kjersten Ostrom-Condojani seconded it. The minutes were approved unanimously. Kelli Anderson abstained.
General Session	 Mr. Dunbar provided S.T.A.M.P. updates to address grading concerns expressed at the last board meeting. Spanish will move to regular grading in Middle School but will remain pass/fail for the remaining grades. For pass/fail classes students will provide self-assessments so there is a dialog with teachers on their progress. Student Council Report: Jordan Graf, student council Treasurer shared their healthy fundraising efforts and impressive updates regarding the Middle School Dance. PTO Report: Total parent volunteer hours year-to-date are which is very strong. The Book Fair and Warren Miller events were extremely successful. PTO helped to brainstorm support for the Capital Committee and will help get families to attend the Charter JeffCo board meeting. Upcoming events include movies with the teachers, a book swap, the talent show, and more.

- **Treasurer's Report:** The Treasurer's Report was provided by Kate O'Rourke. She reviewed the FY 2022 budget. JeffCo lowered PPR but the budget remains stable.
- Principal's Report: Dr. Hudson provided the Principal's Report which highlighted:
 - Educational Excellence highlights Holding mid-year data meetings. Mid-year testing indicated that 84% of students exceed district benchmarks in early literacy skills. The majority of students showed growth in reading and math at mid-year (MAP Testing), but there is still an opportunity to increase those who met/exceeded growth expectations and will be a focus.
 - Sustainability There were some mid-year adjustments, but enrollment is stable at 371. Numerous tours are being given to prospective families. Open Enrollment was delayed due to JeffCo system challenges so it is too early to report on numbers.
 - Shared a high-level proposal regarding a change to the makeup work policy to adjust for more "long-term" absences. This will be discussed further and voted on in the next board meeting.
- Discussed updates from the Charter Renewal
- Discussed safety measures
- Discussed the family handbook updates and RMAE bylaw consistency need
- The Facilities Committee shared updates on the Den and that the project is on budget. Electric and gas are the next big steps for the Den.
- The Capital Committee shared an update on the fundraising efforts the Marketing Committee is assisting the Capital Committee. Ms. Best is going to make sporting good contacts. Mrs. Germano has a connection to volunteer hours with Evergreen High School. Will offer double volunteer hours to parents who volunteer for fundraising at the Den.
- Other Committee Updates: The policy committee and marketing committee provided updates as stated above.
- The next regular board meeting is on February 10th, 2022, at 6:30 PM in the Spanish room.
